- Providing services and support to students with mild to complex mental health and substance abuse issues. The RPN would be consulting with the RN and/or other appropriate members of the health care team when support and/or intervention is required in complex mental health and addiction issues;
- Developing plans for patients with mental health and addiction needs including the transition of students back to school from hospitalization;
- Providing support or intervention for issues such as self-harm or treatment refusal;



- Play a key role in helping students and/or parents' access services such as family health and/or addictions agencies;
- Apply knowledge of nursing process, as it relates to scope of practice, to achieve identified client goals.
